Congress Makes Progress on Tax Extenders, CHIP

CHIP Extension Proposed in Both Chambers

emocrats of the Senate Finance Committee and the House Energy and Commerce Committee have introduced legislation that would extend funding for the Children's Health Insurance Program (CHIP) through fiscal year (FY) 2019. S. 522, the Protecting and Retaining Our Children's Health Insurance Program (PRO-CHIP) was introduced by Sen. Sherrod Brown (D-Ohio) and cosponsored by all of the chamber's Democrats. The bill would be a clean extension of funding for the program, which is currently set to expire at the end of September of this year. H.R. 919, the CHIP Extension and Improvement Act of 2015, was introduced by Ranking Member of the Health Subcommittee Gene Green (D-Texas) and Ranking Member Frank of the full Energy and Commerce Committee Frank Pallone Jr. (D-N.J.). H.R. 919 would also aim to reduce bureaucracy and increase state flexibility in management of the program. The introduction of both bills was widely supported by children's advocacy groups. CHIP provides coverage to approximately 10 million children and has generally received strong bipartisan support. But despite pressure from nearly 40 governors urging Congress to renew CHIP funding, some Republicans feel that the program overlaps with benefits offered under the Affordable Care Act (ACA). Democrats argue that because many states have not expanded their Medicaid programs since the passage of the ACA, up to 2.7 million children could fall into an insurance gap if CHIP is allowed to expire.

Energy and Commerce Advances Six Bipartisan Bills

Last week, the House Energy and Commerce Committee advanced six bipartisan bills dealing with the protection of public health and the modernization of government. The Committee passed by voice vote H.R.

substances for use in clinical trials. The Committee also approved H.R. 471, the Ensuring Patient Access to Effective Drug Enforcement Act, aimed at helping to prevent prescription drug abuse by establishing clear and consistent enforcement standards and promoting collaboration among government agencies, patients, and industry stakeholders. H.R. 647, the Access to Life-Saving Trauma Care for All Americans Act, and H.R. 648, the Trauma Systems and Regionalization of Emergency Care Reauthorization Act, were also advanced. These bills would ensure reauthorization of trauma grant programs.

HELP Discusses Vaccines and Preventable Diseases

There was widespread agreement among Committee members regarding the sound science of vaccination at a hearing on vaccine preventable diseases held by the Senate Health, Education, Labor and Pensions (HELP) Committee. Both parties stressed the importance of immunization, and witness Dr. Anne Schuchat, director of the National Center for Immunization at the Centers for Disease Control and Prevention (CDC), spoke to the recent debate surrounding whether parents should have some choice in whether they vaccinate their children. She testified that there is overwhelming and consistent scientific evidence that vaccines are safe and effective. Further, she and other witnesses stated that an earlier published study linking vaccination to autism was discredited due to fraudulent data and that there is no scientific evidence that vaccines cause mental disorders, a concern voiced many parents who choose not to vaccinate their children. Sen. Barbara Mikulski (D-Md.) and Sen. Susan Collins (R-Maine) expressed concerns about the \$50 million cut to a CDC vaccination program proposed in the President's budget. Dr. Schuchat replied that the CDC would try to offset the impact of these cuts by increasing the billing of insurance for vaccines. There have been 121 cases of measles across 17 states since the beginning of the year, with the outbreak centered at Disneyland in California among people who were not vaccinated.

\$79.2 Billion in Permanent Tax Credits Pass the House

The House of Representatives has passed H.R. 636, a bill combining three small business tax-extender provisions. The legislation includes a \$77.1 billion increase in the amount a small business can deduct from their taxes for the cost of purchases. The bill also contains a measure to extend deductions for S corporations' charitable contributions. H.R. 636 was approved by a vote of 272-142. The bill follows House approval of a package of tax credits for charitable giving earlier last week. Democrats object to the tax extenders because of their impact on the deficit, and the White House has threatened to veto the measures because they contain no offsets. The Senate has also proceeded in taking a stepwise approach to tax code revisions. Lawmakers sent 17 different tax bills to the Senate floor last week.

Affordable Care Act Update

Ryan Announces Plans for ACA Replacement

Louse Ways and Means Chairman Paul D. Ryan (R-Wisc.) has declared plans to release a Republican alternative to the ACA by the end of March as one of his top priorities. Along with House Energy and Commerce Chairman Fred Upton (R-Mich.) and House Education and Workforce Chairman John Kline (R-Minn.), Rep. Paul was appointed to a working group in January by Majority Leader Kevin McCarthy (R-Calif.) to create a comprehensive replacement for the ACA. The focus on preparing an ACA replacement is due in part to the Supreme Court decision in the *King v. Burwell* case expected this spring, which could invalidate health care subsidies for three-quarters of states. Rep. Ryan has reiterated that the replacement plan will not simply tweak language in current law in order to keep federal subsidies in place.



Legislation Introduced to Repeal the Health Insurer Tax

Bipartisan legislation has been introduced in the House to repeal the ACA's tax on health insurance companies. The bill was introduced by Rep. Charles Boustany (R-La.), a cardiovascular surgeon, and Rep. Kyrsten Sinema (D-Ariz.). Rep. Boustany had previously introduced the bill in the 113th Congress with more than 200 co-sponsors. According to the Congressional Budget Office (CBO), the tax would yield \$14.3 billion in revenue by 2018, though the tax could largely be passed to consumers through higher premiums and out-of-pocket costs.

Avalere Releases New Analysis on Specialty Tiers

A ccording to a new analysis, exchange benefit designs increasingly place all medications for some conditions on a specialty drug tier. Avalere Health found that in some exchange plans, drugs used to treat complex diseases such as cancer, HIV, and multiple sclerosis are only included on the highest cost-sharing drug formulary tier. As can be seen in the graph below, Avalere finds that in five of the 20 drug classes reviewed, some plans placed all drugs in a class on the specialty tier. Medications placed on specialty tiers require significant out-of-pocket costs for patients. Specialty tier designs are used by insurance plans in order to increase enrollment through low and stable premiums, which is the main characteristic consumers use for the purpose of plan selection.

Senators Contact CMS Regarding MA Star Ratings

A group of 40 senators led by Sen. Rob Portman (R-Ohio) and Sen. Bill Nelson (D-Fla.) have submitted a letter to the Centers for Medicare and Medicaid Services (CMS) outlining their concerns regarding the star rating system used to provide beneficiaries with a means to assess the quality of Medicare Advantage (MA) plans. A plan's star rating is also tied to quality bonus payments. The senators worry that the star rating system does not accurately assess a plan's performance, which could lead to reduced resources for that plan. This would be especially detrimental for plans serving vulnerable populations. The senators urged the agency to further take into consideration population risk factors and socioeconomic status in determining a plan's star rating.

House Committee Examines ICD-10 Implementation

The House Energy and Commerce Health Subcommittee held a hearing on the subject of ICD-10 implementation, scheduled for October 1st of this year. There was bipartisan agreement that the transition from ICD-9 to ICD-10 should not be further delayed. Dr. Terry, representing the American Urological Association, testified to the physician concerns about losing time with patients while attempting to enter new billing codes, and the potential of ICD-10 implementation resulting in missed payments due to coding errors. Several witnesses at the hearing testified about how ICD-10 will improve data for the purposes of medical research and will facilitate a movement from volume to value driven care.
