### Congress Fails to Reach Budget Caps, Debt Ceiling Agreement Before Memorial Day Recess

Before adjourning for Memorial Day recess, lawmakers appeared to make progress in negotiations on a deal to increase spending caps over the next two years and to raise the debt ceiling beyond 2020. Senate Majority Leader Mitch McConnell (R-Ky.), Minority Leader Chuck Schumer (D-N.Y.), House Speaker Nancy Pelosi (D-Calif.), and Minority Leader Kevin McCarthy (R-Calif.) met with Treasury Secretary Steven Mnuchin, acting White House chief of staff Mick Mulvaney, and acting White House budget director Russell Vought last week. While the meeting concluded without a final agreement, lawmakers seemed optimistic about moving forward with a two-year bipartisan deal to raise spending caps and avoid the potential for another government shutdown. Addressing the debt ceiling deadline, which is projected to occur in September or October, would be a part of the eventual spending deal. The administration appears supportive of bundling a spending caps deal with the debt limit increase. The White House had previously indicated support for a year-long continuing resolution (CR) in the absence of a spending deal, or a one-year instead of two-year agreement, while moving separately on the debt ceiling. Senate Appropriations Chairman Richard Shelby (R-Ala.) also met with the President and senior officials last week to urge the White House not to let sequestration take effect. Sequestration spending cuts are due to take place in January if no deal

is reached. As Congress and the administration continue to work toward a consensus on overall spending levels, Democrats have stated that they remain committed to parity between any spending increases for defense and domestic spending.

Some on Capitol Hill have expressed concerns about the potential impact of the President's recent threat to shut down all bipartisan negotiations in the midst of Democratic investigations into his businesses and taxes. White House officials, however, have stated that the President is still willing to negotiate a budget

agreement with Congress.

While the President's declaration may possibly threaten bipartisan negotiations between Congress and the White House on drug pricing, Senate Finance Committee Chairman Chuck Grassley (R-Iowa) has stated that work to strike a bipartisan deal among members of his panel continues. His package, which is expected to be unveiled sometime in June, will focus on increasing generic competition and possibly include a cap on seniors' Part D out-of-pocket expenses. Sen. Grassley has previously criticized measures to allow Medicare to negotiate prices in Part D, an idea that was being discussed by House Speaker Nancy Pelosi (D-Calif.) in her talks with the White House.

The Senate is scheduled to return from Memorial Day recess on June 3; the House of Representatives will reconvene on June 4.

#### HELP Releases Wide-Ranging Health Care Cost Legislation

Leadership of the Senate Health, Education, Labor, and Pensions (HELP) Committee <u>released</u> a draft bipartisan health care <u>package</u> last week that aims to contain health costs. The bill includes measures to address surprise insurance gaps, reduce the cost of prescription drugs, create more transparency in the health care system, improve public health, and increase health information exchange.

Under the legislation, patients would be required to pay only their in-network cost-sharing amount for out-of-network emergency care and treatments provided by ancillary out-of-network providers. The proposal outlines three options for resolving payment disputes between providers and insurers: an in-network guarantee under which providers can join a health plan's network or bill through the facility where they practice; use of an independent dispute resolution process; or payment based on the median contracted rate for the services rendered. States would have the option of enacting or continuing with current state laws or regulations. If a patient is stabilized after entering a facility through the emergency department, the patient must be given advance notice of any out-of-network care, an estimate of the cost, and referrals for alternative options for in-network care. Health plans and providers would also be required to provide patients with estimates of their out-of-pocket costs for a service within 48 hours of a request, and to send any medical bills within 30 days of the service. Insurers would be mandated to keep their provider directories up to date.

In regard to rising drug costs, the bill would ban the practice of spread pricing by pharmacy benefit managers (PBMs) and require that PBMs provide quarterly reports on costs, fees, and rebates. PBMs would also be required to pass on 100 percent of the rebates negotiated to their client. The HELP proposal would prevent the Food and Drug Administration (FDA) from delaying applications for new insulin products. It also includes provisions to update drug patent registries, increase competition by preventing generic manufacturers from blocking competitors from coming to market, and give the FDA more flexibility in how the agency deals with petitions from brand manufacturers.

The package would prohibit gap clauses between providers and insurers that hide cost and quality information from consumers, as well as anti-tiering and anti-steering clauses in contracts between providers and health plans. It includes funding for programs related to vaccine education, maternal mortality, health care professional discrimination and bias training, and to improve the privacy and security of health information and electronic medical records.

Chairman Alexander has indicated that he is working with members of his panel to add a provision to tie patient costs to a drug's negotiated price rather than its list price, and a measure to require more detailed disclosures from pharmaceutical manufacturers. The HELP Committee plans to hold a hearing on the discussion draft in June before marking it up prior to July 4. The current plan is for the bill to be combined with legislation being drafted by the Finance Committee before being brought to the Senate floor in July. #### House Committees Seek Feedback on Part D Reforms

Bipartisan leadership of the House Energy and Commerce and Ways and Means committees are requesting feedback on draft legislation to reform how Medicare pays for Part D drugs. The bill would place a cap on out-of-pocket prescription drug costs for Medicare beneficiaries based on the current catastrophic threshold and reduce the share of catastrophic coverage costs that the federal government covers from 80 percent to 20 percent over four years. Such reforms generally have bipartisan support among lawmakers. The panels are also soliciting comments on other policies to modernize the Part D benefit structure. #### Doc Caucus Urges Administration to Reconsider Arbitration

The House GOP Doctors Caucus sent a letter to HHS Secretary Alex Azar, Director of the Domestic Policy Council Joe Grogan, and Labor Secretary Alexander Acosta last week regarding surprise insurance gaps. The letter praises the administration for acknowledging surprise medical billing as a significant problem facing American patients and urges the White House officials to look toward successful state models such as the ones enacted in New York and Maryland. The lawmakers argue that the arbitration model based on a third-party charge system is the most appropriate way to address surprise insurance gaps, and request that the administration "reconsider its comments that arbitration would be a disruptive and unnecessary distraction." The letter also highlights the Caucus's concerns with bundled billing and network matching approaches.

#### FDA Appropriations Bill Advances

The House Appropriations Subcommittee on Agriculture, Rural Development, Food and Drug Administration (FDA), and Related Agencies approved its fiscal year (FY) 2020 spending bill by voice vote last week. The legislation would increase spending for the U.S. Department of Agriculture (USDA) and the FDA by \$1 billion for a total of \$24.3 billion in discretionary funding. The FDA would receive \$3.3 billion, \$184 million more in discretionary funding over FY 2019.

#### Lawmakers Request Details on Rates of Maternal Mortality

**B**ipartisan leadership of the House Ways and Means Committee have written to U.S. Department of Health and Human Services (HHS) Secretary Alex Azar and Government Accountability Office (GAO) Comptroller General Gene Dodaro requesting information to better understand the nation's high rate of maternal mortality and the federal government's efforts to address it. Chairman Richard Neal (D-Mass.) and Ranking Member Kevin Brady (R-Texas) ask HHS to provide a comprehensive review of programs and models that combat maternal mortality. They urge the GAO to compile a report detailing the extent of gaps in currently reported maternal mortality data, key inconsistencies in state data reporting, the degree to which such inconsistencies apply to measures of severe maternal morbidity, and the level of federal support necessary to correct them.

#### Senate Finance Continues Insulin Pricing Investigation

Leadership of the Senate Finance Committee have requested information about federal spending on insulin and average out-of-pocket costs for beneficiaries as a part of their investigation into the rising cost of insulin. Chairman Chuck Grassley (R-Iowa) and Ranking Member Ron Wyden (D-Ore.) wrote to Centers for Medicare and Medicaid Services (CMS) Administrator Seema Verma to ask for data on the impact of insulin prices and other diabetes-related costs on both patients and federal health care program spending. The lawmakers also ask for details on how much money pharmacy benefit managers (PBMs) make from insulin rebates and the administrative fees paid by insulin manufacturers.

#### Dems Push Acosta on ACA Information Collection

Democrats in the House are calling attention to the Department of Labor's (DOL) failure to collect transparency data from employer plans as required by the Affordable Care Act (ACA). The ACA requires the Department to collect information on health plans' claims practices, financial disclosures, and enrollment, but the DOL has halted efforts to collect this data from employer-sponsored plans. Chairwoman of the Education and Labor Committee Frederica Wilson (D-Fla.) and Health, Employment, Labor, and Pensions Subcommittee Chairman Bobby Scott (D-Va.) have written to Secretary Alexander Acosta arguing that the missing data inhibits federal enforcement efforts and could be used to protect the 150 million individuals in employer-sponsored plans. They call on the Secretary to come into compliance with the Department's statutory obligations.

#### Lawmakers Release Bipartisan Report on WHO's Use of Opioid Data

Reps. Katherine Clark (D-Mass.) and Hal Rogers (R-Ky.) have released a report detailing the World Health Organization's (WHO) use of data from Purdue Pharma LP in its 2011 and 2012 opioid-related guidance. The report concludes that Purdue-funded organizations and research steered the WHO in its consideration of the safety and efficacy of prescription opioids. The guidance includes the disproven claim that opioid dependency occurs in less than one percent of patients, according to Reps. Clark and Rogers. The lawmakers ask WHO to rescind the guidance, arguing that "a trusted public health organization is trafficking dangerous misinformation that could lead to a global opioid epidemic."

#### New MedPAC, MACPAC Commissioners Announced

The Government Accountability Office (GAO) has announced the appointment of two new members to the Medicare Payment Advisory Commission (MedPAC): Lawrence Casalino, MD, PhD, Livingston Professor of Public Health and Chief of the Division of Healthcare Policy and Economics in the Weill Cornell Department of Healthcare Policy and Research, and Amol Navathe, MD, PHD, co-Director of the Healthcare Transformation Institute and Associate Director of the Center for Health Incentives and Behavioral Economics in the Department of Medical Ethics and Health Policy at the University of Pennsylvania School of Medicine. Their terms will expire in April 2022. The newly appointed MedPAC vice-chair will be Paul Ginsburg, PhD.

The GAO also announced the new members that will be joining the Medicaid and CHIP Payment and Access Commission (MACPAC): Tricia Brooks of Georgetown University and Thomas Barker of Foley Hoag. Melanie Bella, Cityblock Health, was named the new MACPAC chair, while Charles Miligan, UnitedHealthcare, will serve as vice-chair.

#### Health Care Organizations Oppose WH Nondiscrimination Rule

A group of more than 30 health professional associations wrote to U.S. Department of Health and Human Services (HHS) Secretary Alex Azar in opposition of the Department's plans to weaken nondiscrimination protections for lesbian, gay, bisexual, transgender, and questioning (LGBTQ) individuals. Section 1557 of the Affordable Care Act protects LGBTQ populations' access to health care and health coverage and clarifies that discrimination based on gender identity and sex stereotyping is prohibited in health care coverage and access. HHS has proposed to remove the explicit protections from discrimination based on sex stereotyping and gender identity. The organizations underscore the continued stigma and discrimination facing sexual and gender minorities and express opposition to any modifications to regulation that would jeopardize the health and well-being of LGBTQ populations.
